TEAS - Allied Health - This placement test will be available during the month of March for applicants who meet all of the above pre-requisites. **A score of 45 or higher is required on the TEAS in order to move to the next step of the selection process.** Please make sure to check your SWCC college email for notification of testing dates or check with Annette Looney at annette.looney@sw.edu for more information on testing dates.
